Dear Friend of Hardee Habitat,

The board members of Habitat for Humanity of Hardee County, Inc. are excited about a new way you can support our local affiliate.

Since 2002 Habitat for Humanity of Hardee County has successfully constructed 11 homes in Hardee County. This effort has been hindered by limited funds and volunteers, partly due to the demographics in our county and because of a misconception about Habitat for Humanity homeowners. Many people think Habitat GIVES away houses, but that is far from the truth. Our homeowners must put in hundreds of hours to help build their house, known as “sweat equity,” and in turn, we provide them with a low, or no interest mortgage.

We have several affordable housing projects on the books this year and we really need your help. There is an ACH FORM from Wauchula State Bank on the reverse of this letter. This will make it possible for you to help Hardee Habitat with a contribution that can be electronically debited from your bank account each month. The enclosed form should be completed with your name, financial institution, account number, type of account and the transit routing number, a nine-digit number you can get from your bank or off the bottom left side of your checks.

Please consider helping us continue our efforts to provide safe, affordable housing in our community! If you are unable to volunteer your time, perhaps this monthly donation is the perfect way for you to contribute to our endeavors in Hardee County.

Direct ACH Recurring Payment Authorization Form

Here's How Direct ACH Recurring Payments Work:

You authorize regularly scheduled charges to your checking or savings account. You will be charged the amount indicated below each billing period and the charge will appear on your bank statement as an "ACH Debit." Your payments will be made automatically on the specified day. The authority you give to charge your account will remain in effect until you cancel it in writing. You can cancel at any time by notifying your financial institution in writing, 15 (fifteen) days prior to your account being charged.


